The Agreement relates solely to the financing of the Equipment and the Owner's sole obligation will be to allow you quiet use and possession of the Equipment subject to your compliance with the terms of the Agreement. Therefore you confirm and accept that:

- i) The Owner will collect maintenance payments on behalf of the Supplier, however the Owner will be under no obligation whatsoever to provide maintenance in respect of the Equipment and it will be your sole responsibility to enter into a separate maintenance agreement with the Supplier;
- ii) **The Equipment consists of Mailroom equipment however the Rentals (including any maintenance charges incorporated within the Rentals) do not include provision for the supply of any franking/postal charges or the provision of any other services;**
- iii) It will be your sole responsibility to pay for any franking/postal charges and/or other services required by you in respect of the Equipment;
- iv) You will be obliged to pay the Rentals in full even if the Equipment cannot be used for any reason, and/or regardless of any problems or disputes relating to the provision or supply, or failure to supply any franking/postal charges and/or any other related services.

Under the terms of the Agreement you may be required to pay certain fees (such as a one off facility fee and/or an annual service fee) in addition to the Rentals, any such fees will be detailed in the Agreement.
